



Memorandum of Understanding (MOU)

between

The Faculty of Tourism and Hotels, at Alexandria University, Egypt

&

For the Development of Academic Cooperation,
Twinning and Joint Degree Programs

In the mutual interest of the Faculty of Tourism and Hotels, Alexandria University, Egypt (referred to as FTH) and The Departments of "Management" and "Antiquities and Works of Art Preservation", at the Technological Educational Institute of Athens, Greece (referred to as TEI), both parties agree to establish ties of friendship and cooperation for the purpose of promoting mutual understanding and academic, research, cultural, scientific, personnel exchange and training programs of mutual interest as stated in the following articles:

Article (1)

The cooperation between the undersigned two institutions will take the form of (*but not limited to*):

1. Develop Cooperative Programs in Teaching and Research:

- 1.1 Cooperation in the exchange of information relating to teaching and research activities in fields of mutual interest.
- 1.2 Promotion of appropriate joint research projects and joint courses of study, with particular emphasis on internationally funded projects.
- 1.3 Preparation and implementation of joint workshops, workshops and conferences.
- 1.4 Preparation and exchange of joint scientific and educational publications.
- 1.5 Encouragement of students and staff to spend periods of time in the other university.

2. Develop Twinning and Joint Degree Programs:

- 2.1 The MOU provides opportunities for the establishment of twinning and joint degree programs at both the undergraduate and post-graduate levels.
- 2.2 Twinning programs between the respective programs establish the correspondence and equivalency of course work between the two institutions to facilitate the transfer of credit and course work from one to the other.
- 2.3 Joint Degree programs may be offered by both the universities mutual consents.

3. Exchange of staff members, researchers and students:

- 3.1. This MOU facilitates exchange of academic staff members as visiting scholars for teaching assignments, joint research projects or other agreed-upon professional and academic activities. The period of such an arrangement will normally be for one semester, but may be for any period of time agreed upon by the respective academic units and parties. These arrangements may include short courses for specific training needs.
- 3.2 Under this MOU, post-doctoral visits can be established to conduct scientific research according to predetermined programs that are previously approved by the two parties.
- 3.3 Both parties may provide, to a limited number of the counterpart institution students, the opportunity to carry out courses/ training, in one of the fields of mutual interest that will be accepted by both parties.

Article (2)

- 4.1 Both parties recognize that subsequent discussion will be needed to identify priorities and resources for the accomplishment of the goals laid out in this Memorandum of Understanding. Both parties also recognize that their respective academic departments will have a primary responsibility for working out course equivalencies for the joint degree program and developing cooperative programs involving their faculty and staff members.
- 4.2 Subsequent agreements may be negotiated and established for the implementation of specific cooperative programs.

Article (3)

Both parties agree that financial commitments are subject to the availability of appropriate funding.

Article (4)

Exchanged professors will be provided an appropriate office and necessary equipments at the host university. The classes delivered by the guest professor will be included in the curriculum of the receiving institution.

Article (5)

The sending institution will cover the cost of travel tickets and travel insurance for while the receiving institution shall help faculty and students to find suitable accommodation and shall support their academic, social and cultural integration.

Article (6)

Both parties shall establish a link for the other party to appear on its formal website.

Article (7)

Each party shall designate a contact person to facilitate the implementation of this MOU.

Article (8)

If a conflict arises between the two parties concerning the implementation of the articles of the MOU, the two parties will settle in amicably or they will refer to a jury agreed upon by the two parties and governed by the law of judgment no. 27/ 1994.

Article (9)

This MOU will take effect from the date of its signing and shall be valid for a period of five years from that date, unless terminated earlier upon six months' notice by either



party. The MOU may be revoked or modified by mutual agreement, between the parties, and may be extended beyond its initial five-year term by mutual agreement.

Article (10)

The two copies in Arabic and English of this agreement are equally valid. In case of conflict, the two parties would refer to the English text.

This MOU has been prepared by authorized representatives.


